This is to certify that I, or as a **parent or guardian** with legal responsibility for the participant 18 or younger, identified above, acknowledge and agree that ice skating is an inherently risky activity, the Minor Participant's participation is voluntary, and the Minor Participant is qualified, in good health, and in proper physical condition to participate therein. I further acknowledge and understand that Minor Participant will be engaging in activities that involve the risk of serious injury, which may result from each one's participation, and/or the action, inaction, and/or negligence of other parties. I further understand and agree that this activity may involve risks not known to me or to the Minor Participant, or that are not reasonably foreseeable to me or to Minor Participant. I acknowledge that I have investigated and evaluated the risks and have made a voluntary and informed decision about engaging in the activities. My decision to sign this Release is based upon my own investigation and understanding, and not the representations of the Released Parties. Accordingly, on behalf of Minor Participant, I hereby hold harmless, release, discharge, waive, covenant not to sue, indemnify, and defend The Delaware State Fair, Inc. and its respective agents, affiliates, subsidiaries, associates, officers, directors, and employees (the "Skating Parties") from any and all liabilities, responsibilities, claims, demands, losses, injuries, costs, and causes of action arising out of, or related to, my use or presence at the skating Arena, whether or not caused by negligence or other fault of the Skating Parties. Further, I agree to allow, without compensation, the Minor Participant's likeness and/or name to appear, and to otherwise be used, in material, regardless of media form, promoting The Delaware State Fair, Inc.'s Centre Ice Arena.

Exposure to COVID-19 is an inherent risk in any public location where people are present; The Delaware State Fair, Inc. cannot guarantee the Minor Participant will not be exposed during your visit. The CDC advises that older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from Coronavirus.
