I acknowledge and agree that ice skating or recreating on ice in any form (i.e. ice bumper cars, ice broomball, curling, etc.) is an inherently risky activity, my participation is voluntary, and I am qualified, in good health, and in proper physical condition to participate therein. I further acknowledge and understand that I will be engaging in activities that involve the risk of serious injury, which may result from my participation, and/or the action, inaction, and/or negligence of other parties. I further understand and agree that this activity may involve risks not known to me, or that are not reasonably foreseeable. I acknowledge that I have investigated and evaluated the risks and have made a voluntary and informed decision about engaging in the activities. My decision to sign this Release is based upon my own investigation and understanding, and not the representations of the Released Parties. I hereby expressly and specifically assume the risk of injury or harm in the activities and release the Released Parties from all liability for any loss, cost, expense, injury, illness, death or property damage resulting directly or indirectly from the activities. Accordingly, I hereby hold harmless, release, discharge, waive, covenant not to sue, indemnify, and defend The Delaware State Fair, Inc. and its respective agents, affiliates, subsidiaries, associates, officers, directors, and employees (the "Released Parties") from any and all liabilities, responsibilities, claims, demands, losses, injuries, costs, and causes of action arising out of, or related to, my use or presence at the skating Arena, whether or not caused by negligence or other fault of the Released Parties. Further, I agree to allow, without compensation, my likeness and/or name to appear, and to otherwise be used, in material, regardless of media form, promoting The Delaware State Fair, Inc.'s Centre Ice Arena.

Exposure to COVID-19 is an inherent risk in any public location where people are present; we cannot guarantee you will not be exposed during your visit. The CDC advises that older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from Coronavirus.
