Proposed Pricing for DSF Stage

- Three categories of pricing:
 - Flat rate for casino usage
 - Pricing for non-commercial/non-ticketed "bolt on" to existing relationship (Girl Scouts, Good Sam Club, etc.)
 - Pricing for commercial, ticketed event produced by outside promoter

Pricing Structure 1: Flat Rate for Casino Usage

- \$20,000 Flat Fee
- Inclusive of:
 - Stage with scrim up and tech huts installed
 - Grandstand and Grandstand Restrooms cleaned (clubhouse excluded from pre-cleaning)
 - Access to track seat inventory
 - DSF Maintenance equipment

Casino Usage Conditions

- DSF Stage manager, stage crew, equipment operators, riggers and ushers must be contracted through DSF or independently as needed
- DSF ticketing system must be used for online sales and day of event box office; on-site sales to be handled by casino
- Vending free to offer any combination of inhouse or third-party food, beverage, alcohol and merchandise without additional fees due Fair

Casino Pricing: Exclusions

- Sound, Lights and Video Walls
- Labor to install and remove track seating
- Post-event cleanup
- Shower, dressing room and production trailers

Pricing Structure 2: Add-On to Existing Rental Event; 4H or FFA Usage

- Flat fee of \$2,000
- Inclusive of:
 - Stage with scrim up (tech huts excluded)
 - Grandstand and Grandstand Restrooms cleaned (Clubhouse excluded)
- Event must be a "soft ticket" event
- Ancillary equipment or personnel charges, such as track seat usage and installation, ushers/ticket takers, barricades, tables, etc., subject to prevailing rental rates

Conditions for Usage

- DSF Stage manager, stage crew, equipment operators and riggers must be contracted through DSF as needed
- Event must be a "soft ticket" or free general-admission event
- Vending
 - Food and non-alcoholic beverages may be offered by promoter or any third party without additional fees due Fair
 - Artist merchandise may be sold by the promoter or any third party without additional fees due Fair
 - Alcoholic beverages must be sold by Harrington Raceway;
 Promoter must negotiate independently and directly with Harrington Raceway regarding any commissions

Exclusions

- Sound, Lights and Video Walls
- Labor to install and remove track seating
- Post-event cleanup
- Shower, dressing room and production trailers

Pricing Structure 3: Outside Promoter

- Flat fee of \$3,000 or 10% of gross revenueproducing ticket sales, whichever is greater
- Applies to "hard-ticketed" events
- Inclusive of:
 - Stage with scrim up and tech huts installed
 - Grandstand and Grandstand Restrooms cleaned (Clubhouse excluded)

Conditions for Usage

- DSF Stage manager, stage crew and riggers must be contracted through DSF as needed
- Vending
 - Food and non-alcoholic beverages may be offered by promoter or any third party without further charge
 - Artist merchandise may be sold by the promoter or any third party without further charge
 - Alcoholic beverages must be sold by Harrington Raceway; Promoter must negotiate independently and directly with Harrington Raceway regarding any commissions

Exclusions

- Sound, Lights and Video Walls
- Labor to install and remove track seating
- Post-event cleanup
- Shower, dressing room and production trailers

Overview of Proposed Rental Rates

- \$20,000 Flat Fee for Casino Usage
- \$2,000 Flat Fee for "soft ticketed" events in conjunction with existing rental event or for 4H/FFA events
- \$3,000 Flat Fee, or 10% of gross, whichever is greater, for outside promoters
