## Arrival & Departure:

- Pen assignments will be posted during the check-in times by Superintendent Brian Somers between Wednesday, July 22, 8:00 AM through Saturday, July 25, at 8:00AM. 
- All Hogs (Market and Breed) may begin to arrive Wednesday, July 22, starting at 8:00 AM and MUST be in place by Friday, July 24 at Noon.
  - Market Hogs (excluding animals making the Junior Livestock Auction) will begin to leave the grounds Monday, July 27, at 12:01 AM and must be removed from the grounds by Monday, July 27, at 9:00 AM.
  - Boar Breed Hogs may begin to arrive Monday, July 27 at 6:00 AM and MUST be in place by Monday, July 27 at 9:00 AM. Boars may leave after midnight that night.
  - All remaining hogs may be removed from the grounds on Sunday, August 2, at 1:00 AM and MUST be removed from the grounds by Sunday, August 2, at 8:00 AM

3. In order to drop off animals on the grounds, please have your vehicle pass in the bottom driver's side front windshield to be permitted onto the grounds.
4. All animals may not leave the grounds before Sunday, August 2, at 1:00 AM.
5. Animals removed before Sunday, August 2, at 1:00 AM will result in forfeited premiums.
6. The Swine Department will only be allowed access through Gate 2 for arrival and departure. Please refer to the map of the fairgrounds in the [Livestock Handbook](#).

### **Entry Information & Fees:**

1. Entries can only be made online via the [Fair's website](#) beginning 9:00 AM April 1, 2026 thru 11:59 PM June 1, 2026.
2. A \$10.00 entry fee per class (excluding groups, pairs, showmanship, fitting & contest classes) is required for all show entries.
3. Each exhibitor may show no more than two (2) entries in any class. When there are two or less entries in a class, the superintendent may move such entries into "Any Other Breed" class. For purposes of this rule, Exhibitors to be counted shall include the adult owners of a farm or business entity in whose farm or business name an animal may be registered. For more information refer to Rule 3, General Animal Rules, Section D, Ownership.
4. It is the responsibility of each exhibitor to read all [General Animal Exhibitor Rules on the Fair's website](#).
5. Entries are restricted to Delaware residents and active Delaware 4-H members regardless of residency.
6. Exhibitor back tag numbers will be supplied by the Delaware State Fair. The number must be worn whenever the exhibitor is in the show ring.

### **General Rules & Regulations:**

1. All animals are subject to be used in Livestock Judging Contests for 4-H or FFA and the Livestock Extravaganza.
2. Due to new fans installed in the Kent Barn, portable fans will not be permitted.
3. **If the number of hogs entered exceeds the number of pens available, then a waiting list will be established as determined by the time and date of entry.**
4. During shows, no photographers are permitted in the ring except for the official photographer. Please take photos from behind the fencing; remaining outside of the ring.
5. Exhibitors should wear appropriate show attire while in the show ring e.i. collared shirts, jeans and boots. Please refrain from plunging necklines, sleeveless shirts, shorts or open toed shoes. Anyone not in proper attire will be asked to leave the show ring.

### **Swine Department Rules & Regulations:**

1. Animals showing any signs of being unethically fit will be disqualified. Please refer to the Delaware State Fair Livestock Handbook for the Code of Showring Ethics. For swine, you may use skin conditioners. Paint conditioners can be used on existing colors but may not be used to attempt to change the color pattern or alter any aspect of breed character.
2. There will be no Registered Barrow classes. All barrows (purebred and cross) will be shown as Dark Cross or Light Cross in the Open Barrow Show on Sunday. A "Light Cross" pig is one with primarily white or blue pigmentation, may have small areas of black pigment like on the snout or toes. A "Dark Cross" pig will have significant black or red pigmentation with a black or red belted pattern, large dark patches or a black head. Light Cross and Dark Cross classification will be determined at weigh-in.
3. Weight Requirements
  - a. All Open Barrows and Crossbred Gilts must weigh between 200 lbs. min - 300 lbs. max at weigh-in. Animals unable to meet this requirement will be dismissed from the fairgrounds immediately and may not be exhibited.

- b. All Junior Market Hogs must weigh between 220 lbs. min - 290 lbs. max at weigh-in. Animals unable to meet this requirement will be dismissed from the fairgrounds immediately and may not be exhibited unless eligible for the Junior Commercial Gilt Class or the Open Barrow Class.
4. Please note the following weigh-in/tagging dates and minimum weight requirements:

### Registration Papers:

1. All swine under 6 months must be prepared to prove eligibility for registration and all swine over 6 months must be registered with their respective breed registry departments.
2. All Berkshire swine must be registered by the American Berkshire Association (ABA), P.O. Box 2436, 1769 US 52 West, West Lafayette, IN 47996. The ABA is the only Berkshire swine registry recognized by the National Association of Swine records (NASR) and the National Pedigreed Livestock Council (NPLC).
3. Registration papers will be checked on Sunday between 2PM - 4PM in the Kent Building.
4. The Association reserves the right to reject any entry not in show condition.

### Pens & Barn Cleanliness:

1. All pens are to be cleaned by 11:00 AM daily. No washing hogs after 11:00 AM except on show days.
2. **Please be sure to note clearly on your entry who you wish to be penned with or near and their contact number.**
3. Pen assignments will be posted during the check-in times by Superintendent Brian Somers between Thursday, July 23, 8:00 AM through Saturday, July 26 at 8:00AM.
4. **FFA ADVISORS** – Fax (302-398-5030) or email ([premiums@thestatefair.net](mailto:premiums@thestatefair.net)) a list of members and entries to the Fair office by June 1st so chapters may be penned together.
5. Pens must be kept in good condition, i.e. NO ODOR! Sloppy, dirty or stinking pens as well as empty or dirty water buckets will not be tolerated. There will be one warning and the second time the exhibitor will be asked to leave, thus forfeiting premiums.

### Adding or Eliminating Breeds:

1. A new breed class will be created if there are 6 or more animals represented by 3 owners for 2 consecutive years.
2. If a breed class is not represented by 6 or more animals and 3 owners for 2 consecutive years, then that breed class will be eliminated and the animals will be entered in all other breeds.

### DE Bred & Owned Rules:

1. There may only be one person listed as the breeder and the owner to be eligible for the Bred & Owned Division.
2. The exhibitor's first and last name must be listed on the pedigree as the owner and breeder to be eligible for the Bred & Owned division.
3. The Owner Number and the Breeder Number must be identical to be eligible for the Bred & Owned Division.
4. No farm names or partnerships can be listed to be eligible for the Bred & Owned Division.
5. The exhibitor must have owned the dam at the time of breeding.

- 6. Exhibitors **MUST** declare that his or her gilt is eligible for Bred & Owned awards at registration/check-in. If you do not declare this designation at the time of check-in/registration you will **NOT** be eligible to show in the Bred & Owned division.
- 7. Exhibitors must be a **DE resident** regardless of 4-H/FFA membership.

### MARKET HOG CONTEST

Rules:

1. All junior market animal exhibitors MUST complete a Youth for the Quality Care of Animals (YQCA) training certification class (online or in-person), unless they have an existing Youth Pork Quality Assurance (YPQA) certification that is valid through August 1, 2026. The YQCA training certification course can be done either in person or online, **but must be completed to enter a market animal in the 2026 Delaware State Fair. Exhibitors will be asked upon entry to provide their YQCA certification before moving forward with their entries.**
  - a. This mandatory training requirement shall apply to all those exhibiting market animals. The training certification is not limited to only market animal exhibitors and all exhibitors are encouraged to consider completing this course.
  - b. If you are a junior market animal exhibitor and have not attended or completed the online YQCA course nor currently have an existing YPQA valid certification **by the deadline (June 1, 2026)**, you will not be permitted to show your market animal(s).

2. Market animals can upload a photo of their animal until **July 1, 2026**.
3. Without a PQA/YQCA certificate, your hog WILL NOT BE PERMITTED TO SHOW!
4. Each exhibitor in the Market Hog Contest shall show no more than 2 hogs in the contest. Only one entry per exhibitor per weight class will be accepted. If two market animals entered by the same exhibitor are determined to be in the same weight class, the exhibitor shall select one of the two animals to be moved up to the next higher weight class thereby allowing the exhibitor the opportunity to show both animals. If two market animals entered by the same exhibitor are determined to be in the heaviest weight class, the exhibitor shall choose which animal will be struck from the competition.
5. Hogs must not be farrowed before January 1, and must be tagged with Delaware State Fair ear tags.
6. All Junior Market Hogs must weigh between 220 lbs. min - 290 lbs. max at weigh-in. Animals unable to meet this requirement will be dismissed from the fairgrounds immediately and may not be exhibited. No re-weighing will be permitted.
7. The number of classes will be determined after weigh-in.

### JUNIOR BREED SHOW

Rules:

1. Exhibitors in the junior breed show may enter the same animals in the open show.
2. One entry per exhibitor in each class will be accepted.
3. Active Delaware 4-H members are permitted to exhibit in youth livestock shows regardless of residency.
4. The open crossbred market gilt class winners do not go to the auction on Thursday night. Each entrant must be prepared to prove ownership by the person in whose name entry is made.
5. All breeding and market hogs should be in show condition; if not they will be asked to leave the Fairgrounds
6. The Hampshire breed will be shown in "Any Other Breed" due to low entries for the past 3 years.
