



2026 INSTRUCTIONS

FOR ONLINE PROXY VOTE & OBTAINING YOUR 10-DAY GATE PASS

STEP 1.

In the body of the email you received from **shareholder@thestatefair.net**, click on the red button that looks like the red box pictured to the right that reads "VOTE YOUR PROXY AND CLAIM YOUR 10-DAY GATE PASS"

STEP 2.

You will be taken to **ETIX** on a new screen. ETIX is our authorized ticketing platform used to sell and distribute Fair tickets. Click the dropdown arrow next to the number of registrants, select "1", then click "**Register**".

STEP 3.

You will be prompted to enter your Shareholder Control ID Number, the 5 digit ID will start with an UPPER-CASE Letter "**D**" followed by **4 NUMBERS**.

(example: **D1234**)

Your Shareholder ID number can only be used one (1) time to claim your gate pass.

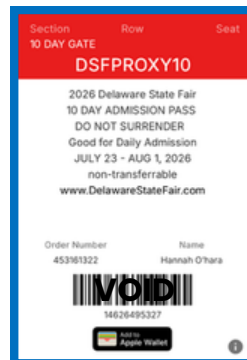
